Notes:

1. Winter Break is December 19, 2020 to January 3, 2021 (+16); Thanksgiving Break is November 21, 2020 – November 29, 2020 (+9)
2. All IEPs with due **dates that fall on a Saturday, Sunday or during a Holiday that falls on a school day** (e.g. Memorial Day), or during a school break of no more than five school days (e.g., Thanksgiving, Spring and Winter Breaks) **must be convened by the school day PRIOR to the start of the weekend, break or holiday.**
3. The IEP due date for signed Consent for Assessment Plan-Parent Notice forms received from **May 12th – June 10th is 30 days after school starts in August, 2021.**
4. The timelines are calculated using
 - **June 4, 2020 as the last day of the 2019-20** school year.
 - **August 25, 2020 as the first day of school and June 10, 2021 as the last day of the 2020-21** school year, and **August # (unknown), 2021 as the first day of the 2021-22** school year.

Education Code Section 56344(a): Timeline for holding IEP meeting following assessment. 56344. (a) An individualized education program required as a result of an assessment of a pupil shall be developed with a total time not to exceed 60 days, not counting days between the pupil's regular school sessions, terms or days of school vacation in excess of five schooldays, from the date of receipt of the parent's written consent for assessment, unless the parent agrees, in writing, to an extension.

However, an individualized program required as a result of an assessment of a pupil shall be developed within **30 days after the commencement of the subsequent regular school year** as determined by each local educational agency's school calendar for each pupil for whom a referral has been made **30 days or less prior to the end of the regular school year.**

In the case of pupil **school vacations, the 60-day time shall recommence on the date that pupil schooldays reconvene.** A meeting to develop an initial individualized education program for the pupil shall be conducted within 30 days of a determination that the pupil needs special education and related services pursuant to Section 300.323(c)(1) of Title 34 of the Code of Federal Regulations.

(b) Pursuant to Section 300.323(c)(2) of the Title 34 of the Code of Federal Regulations, as soon as possible following development of the individualized education program, special education and related services shall be made available to the individual with exceptional needs in accordance with the individual's individualized education program.

(c) Each local educational agency shall have an individualized education program in effect for each individual with exceptional needs within its jurisdiction at the beginning of each school year in accordance with subdivision (a) and pursuant to Section 300.323(a) and (b) of Title 34 of the Code of Federal Regulations.
